REGULATIONS

1. The submission of the **SUMMER LAB'26** form constitutes a pre-registration, subject to validation by Play False | associação cultural and CAEV/Teatro Viriato, hereinafter also referred to as the "organising parties". Upon confirmation of registration by the organising parties, the participant must pay the full registration fee or pay 20% of the amount corresponding to the group in which they wish to register (groups A and B: €48 / group C: €30) – undertaking, in the latter case, to pay the remaining balance no later than **June 5th 2026**. If they choose to take advantage of the accommodation selected by the organising parties, the registration fee is increased in the amount corresponding to the full payment of the type of room chosen (single or shared room). All payments must be made through bank transfer to IBAN PT50 0010 0000 3196 0450 0012 8. Proof of payment (identifying the individual being registered) and all other registration required documentation (duly filled in and signed) should then be sent to bilheteira@teatroviriato.com. Otherwise, the participant will be unable to attend the programme.
2. In the case of participants under the age of eighteen, in addition to the steps indicated in the previous section, the relevant authorisation for the minor's participation in SUMMER LAB'26, duly filled in and signed by a legal guardian, must also be sent to bilheteira@teatroviriato.com, together with proof of payment. This document will be available for download on the Play False and Teatro Viriato websites. Without this authorisation, underage participants will be unable to attend the programme.
3. It is the participant's responsibility, at time of registration, to choose which group they wish to join. To join group A, the participant must provide proof of qualifications.
4. All documentation pertaining to participation in SUMMER LAB'26 — Regulations, Schedule, Consent for Image Capture and Usage (for adults and minors) and Underage Participation Authorisation – are available for download on the page concerning this activity on Play False's and Teatro Viriato's websites.
5. Play False and Teatro Viriato reserve the right to cancel all SUMMER LAB'26 activities for reasons of force majeure, reimbursing participants for the total amount already paid concerning attendance of this training programme and accommodation booking, where applicable, but they will not be held responsible for any other expenses incurred by participants.
6. If the announced instructors are unable to attend, or if their presence is prevented for reasons unavoidable, the organising parties will ensure their replacement by other professionals of equivalent quality and recognition.
7. In the event of a last-minute cancellation by the participant (any cancellation from June 6th 2026

onwards), the amount paid will not be refunded by Play False or Teatro Viriato, since any slot on the participant roster involves logistical and artistic commitments undertaken in advance by the organising parties.

8. Participants may choose to attend only some SUMMER LAB'26 subjects, although the amount to be paid remains the same as that defined for the full programme.
9. Classes will take place between July 20th and 24th, 2026, from Monday to Friday. For groups A and B, there will be five classes per day and, for group C, two classes per day. All schedules will be made available on Play False's and Teatro Viriato's websites.
10. Image capture (through video and/or photography) during classes is strictly forbidden. If participants wish to take photographs or record videos while participating in SUMMER LAB'26 activities, they may do so outside the context of classes. Whenever such content is shared, we ask that you please tag the social media profiles of Play False ([@playfalse_associacaocultural](#)) and Teatro Viriato ([@teatro_viriato](#)).
11. All participants are informed that SUMMER LAB'26 activities may be photographed and/or video recorded by Play False and Teatro Viriato, exclusively for the purposes of promoting and archiving the project. Participants will not be granted any right to claim ownership over such materials. If you do not want to authorise the capture of your image, you must indicate
12. Play False and Teatro Viriato are not responsible for supervising participants, whether adult or underage, outside the scheduled activity hours, including at their accommodation (whether selected by the organising parties or not).
13. All SUMMER LAB'26 activities are covered by a Group Personal Accident insurance policy, in force from 9:30am on July 20th until 7:15pm on July 24th, 2026. This policy covers only activities taking place within Teatro Viriato as part of the SUMMER LAB'26 programme.
14. Participants undertake to respect all pedagogical and safety instructions given by the instructors, as well as by the Play False and Teatro Viriato teams. The organising parties reserve the right to interrupt the participation of any given participant whose conduct places their physical integrity, or that of others, at risk without entitlement to a refund.
15. If the participant has any health related issues that are relevant to, or may interfere with, their participation in the activities, this information must be communicated to the organising parties, in writing, on the participant's registration form.
16. At the end of the SUMMER LAB'26 programme, participants will be awarded a certificate of participation describing the attended subjects, as well as their respective instructors and course load.
